# Australian PDV Screen Incentives

## 30% POST, DIGITAL & VISUAL EFFECTS OFFSET

A tax rebate of 30% calculated on qualifying post, digital and visual effects (PDV) production expenditure. The production must have a total PDV-related qualifying Australian Production Expenditure (QAPE) of at least AU\$500,000. A production does not need to be filmed in Australia.

<b>PDV (POST, DIGITAL &amp; VFX) OFFSET</b>	AU\$500,000	Tax Rebate is paid to the Applicant.  Payment is usually made in four weeks after lodgement with the Australian Taxation Office.
<b>FEDERAL REBATE %</b>  <b>30%</b>	<b>QUALIFIERS</b>  Feature, TV series (incl. documentary, reality, animation), TV mini-series. Web series or film may be eligible if the intent is to be distributed through a curated platform e.g YouTube Premium. A distribution agreement or other documentation will be required.  Productions do not have to be filmed in Australia.  Cannot be combined with Location or Producer Offset.	
<b>STATE REBATE</b>  Can be combined with state and territory incentives and grants.		<b>CULTURAL TEST, SUNSET OR CAP</b>  No expenditure cap or sunset. No cultural test.

<b>STATE REBATE %</b> <b>10%</b>	<b>QUALIFIERS</b> Spend on qualifying PDV in New South Wales. Applicants must register project prior to PDV commencement.		
<b>ADMINISTERED BY</b> <b>Screen NSW:</b> pdvgames@screen.nsw.gov.au		<b>CULTURAL TEST, SUNSET OR CAP</b> No cultural test.	
<b>QUEENSLAND PDV INCENTIVE</b>	<b>MINIMUM QPE^ SPEND</b> AU\$250,000	<b>BENEFITS</b> Up to <b>45% REBATE</b> on your <b>Queensland spend</b> when you combine with <b>Federal 30% PDV Offset</b> . You can also combine with Gold Coast Film Commission incentives.	
<b>STATE REBATE %</b> <b>UP TO 15%</b>	<b>QUALIFIERS</b> Spend on qualifying PDV in Queensland. Applicants must apply prior to PDV commencement.		
<b>ADMINISTERED BY</b> <b>Screen Queensland:</b> nwenck@screenqld.com.au		<b>CULTURAL TEST, SUNSET OR CAP</b> Capped. Case by case. No significant Australian cultural test.	
<b>SOUTH AUSTRALIA PDV REBATE</b>	<b>MINIMUM QPE^ SPEND</b> AU\$250,000	<b>BENEFITS</b> <b>40% REBATE</b> on your <b>SA spend</b> when you combine with <b>Federal 30% PDV Offset</b> .	
<b>STATE REBATE %</b> <b>10%</b>	<b>QUALIFIERS</b> Spend on qualifying PDV in South Australia. Projects must be formats supported by the Federal PDV Offset.		
<b>ADMINISTERED BY</b> <b>South Australian Film Corporation:</b> programs@safilm.com.au		<b>CULTURAL TEST, SUNSET OR CAP</b> No cap. No cultural test.

<b>STATE REBATE %</b> <b>UP TO 10%</b>	<b>QUALIFIERS</b> Spend on qualifying PDV in Victoria.	
		<b>CULTURAL TEST, SUNSET OR CAP</b> Capped. Case by case. No cultural test.
<b>ADMINISTERED BY</b> <b>VicScreen:</b> joe.brinkmann@vicscreen.vic.gov.au		

<b>WESTERN AUSTRALIA PDV INCENTIVE</b>	<b>MINIMUM QPE^ SPEND</b> AU\$100,000	<b>BENEFITS</b> <b>50% REBATE</b> on your <b>post/VFX Qualifying WA Expenditure (QWAE)</b> when you combine with the <b>Federal 30% PDV Offset</b> .
<b>STATE REBATE %</b> <b>20%</b>	<b>QUALIFIERS</b> Spend on qualifying post/VFX in Western Australia.  Applicants must apply prior to PDV commencement. The WA PDV Incentive is effective 1 July 2025 onwards.	
		<b>CULTURAL TEST, SUNSET OR CAP</b> Capped. Case by case. No Cultural test.

## *But wait, there's more!*

### **Claim Companion Travel, Accommodation & Per Diems**

If contracted a production can claim:

50% of the airfare and 100% accommodation and per diems for ATL and BTL crew working in Australia for 2 or more consecutive weeks.

50% of the airfare and 100% accommodation and per diems can be claimed for cast travelling to Australia to complete ADR.

100% airfare and accommodation for companions of ATL and BTL crew, if part of remuneration contract.

### **Claim ATL Wages**

Director and crew (e.g editors, Post/VFX Supervisors) fees if in Australia for 2 or more consecutive weeks.


























### **Claim Music Clearances**

Clearance (music, photographs, archival footage) where copyright is held by an Australian.

### **Claim Stock**

Stock footage where copyright is held by an Australian.
